Introduction :

The Central Government has decided to establish residential schools for tribal students at the state level out of the funds disbursed vide article 275 ( 1 ) of the Constitution of India with the objective of providing quality education to the students from the scheduled tribes category. In terms of Tribal Development Department Government Resolution dated 11th September 2000, Eklavya Residential Schools having classes from 6th to 12th standard as per the Central Board of Secondary Education New Delhi curriculum, were established for the tribal students at 1 ) Nasik ( Nasik ) 2 ) Kambalgaon ( Thane ) 3 ) Chikhaldara ( Amravati ) 4 ) Khairi Parsoda

Nagpur ) since the year 2001 , in the first stage. Similarly the teaching and non teaching staff fo these schools and their pay scales were also stipulated.

As per Central Government recognition, 16 Eklavya residential schools for the aboriginal / primitive tribes are currently functional under the Tribal Development Department. Out of which the Tribal Development Department has not issued formal recognition orders in respect of two schools at Charmoshi in Gadchiroli district and Titwe in Nasik district. As such consdering the grant in aid becoming available from the Central Government under section 275 ( 1 ) of the Constitution of India, the matter of establishing Eklavya residential schools at 10 locations was under the consideration of the Government. Accordingly the Government is taking the following decision

Government Resolution :

The Government is hereby approving the establishment of Eklavya Residential Schools having classes from 6th to 12th standard as per the Central Board of Secondary Education New Delhi curriculum,were established for the tribal students at the following locations :

1. Charmoshi District Gadchiroli	7 . Nawapur District Nandurbar
2. Titawe District Nasik	8. Akkalkuwa District Nandurbar
3. Pandharkawada District Yavatmal	9. Kalwan District Nasik
4. Dhadgaon District Nandurbar	10. Kurkheda District Gadchiroli
5. Savane Talasari District Palghar	11. Surgana district Nasik

6. Jawhar District Palghar

Education as per the Central Board of Secondary Education New Curriculum, shall be imparted to the students in the aforesaid schools.

2. The provisions contained in the Government Resolutions under reference no 1 and 2 shall be applicable to the aforesaid 10 Eklav residential schools.
